### **NOTICE OF PRIVACY PRACTICES**

**THIS NOTICE DESCRIBES HOW MEDICAL AND DRUG AND ALCOHOL RELATED INFORMATION ABOUT YOU MAY BE USED AND DISCLOSED, AND HOW YOU CAN GET**

**ACCESS TO THIS INFORMATION. PLEASE REVIEW IT CAREFULLY.**

Gaudenzia, Inc. (“Gaudenzia”) is required to abide by the terms of this notice. The medical information we maintain may come from any of the providers from whom you have received services. The medical information we record and maintain is known as Protected Health Information, or PHI. We will not use or disclose your PHI without your permission, except as described in this notice.

Information regarding your health care, including payment for healthcare, is protected by two federal laws: the Health Insurance Portability and Accountability Act of 1996 (HIPAA), 42 U.S.C. §1320d et seq., 45 C.F.R. Parts 160 & 164, and the Confidentiality Law, 42 U.S.C. § 290dd-2, 42 C.F.R. Part 2. Under these laws, Gaudenzia may not say to a person outside Gaudenzia that you attend the program, nor may Gaudenzia disclose any information identifying you as an alcohol or drug user or disclose any other PHI except as permitted by federal law.

We reserve the right to change our practices and to make the new provisions effective for all medical information we maintain. Should our medical information practices change, we will amend this notice and post a notice of the changes,



which will be made available to anyone upon request. This notice is effective as of January 1st, 2023.

### **USES AND DISCLOSURES:**

Gaudenzia must obtain your written consent before it can disclose information about you for payment purposes. Generally, you must also sign a written authorization before Gaudenzia can share information for treatment purposes or for healthcare operations. However, federal law permits Gaudenzia to disclose information without your written permission for the following:

1. Pursuant to an agreement with a person or agency that provides services to Gaudenzia.
2. For research, audit or evaluation.
3. To report a crime committed on Gaudenzia premises or against Gaudenzia personnel.
4. To medical personnel in a medical emergency.
5. To appropriate authorities to report suspected child abuse or neglect.
6. As allowed by a court order.

Before Gaudenzia can use or disclose any information about your health in a manner which is not described above, it must first obtain your specific written authorization allowing it to make the disclosure. You may revoke any such written authorization in writing, except to the extent that we have already acted on it.

### **WHAT ARE YOUR RIGHTS? YOU HAVE THE RIGHT TO:**

- Request restrictions on certain uses and disclosures of your Protected Health Information (PHI).
- Receive reasonable confidential communication of PHI, e.g., contact you at a place of your choosing.
- Inspect and copy your medical record by written request, with some exceptions. Gaudenzia reserves the right to deny the request, to which you may make a further appeal.



- Request an amendment of your medical record. Gaudenzia reserves the right to deny the request, to which you may make a further appeal.
- Receive an accounting of Gaudenzia disclosures of your PHI during the six years prior to your request.
- Accountings of disclosures start as of January 1st, 2023 and are unavailable prior to that time.
- Receive a paper copy of this notice.

### **HOW CAN YOU REPORT A PROBLEM?**
